**Description:** The New York State Bridge Authority is soliciting bids for the "Deck Replacement" project at the Bear Mountain Bridge in Fort Montgomery, New York. The scope of work involves deck removal and replacement, new concrete barrier at the curb line, bridge sidewalk removal and widening and furnishing and installation of deterrent fencing. The project shall include all stages of the work-zone traffic control, furnishing and installation of all materials, access, installation and removal of approved "scaffolding/shielding" system and isolated lead abatement at location(s) shown on the contract drawings.
